Carnival Day Camp will operate from 7:00am to 7:00pm on Saturday August 3rd, 2019 inside Parkway Forest Community Centre at 55 Forest Manor Road, Toronto, ON.

7. Carnival Day Camp will be notified by 5:30pm if parent/guardian will be late picking up their child.

ELECTRONIC GAMES AND DEVICES

Your child may bring electronic devices to the camp but we will not be responsible for illegal internet access or data overages from your provider. We allow the use of these devices but do not rely on them to keep your child entertained. We will not be responsible for breakage or loss of such devices and strongly encourage you to label them with the child's name.

LATE

Should I pick up my child late, I authorize Carnival Day Camp to charge my credit card \$2/minute after the agreed upon pick up time. If I do not have a credit card, I authorize Carnival Day Camp to deduct the late fee from the deposit provided.

MEALS

Carnival Day Camp will provide nutritious meals and snacks at regular meal times unless special arrangements are made. We ask that you send your child with a reusable water bottle and change of clothes.

NUT ALLERGIES

Our food service does not serve peanut butter or nuts of any kind.

We ask that parents and caregivers refrain from sending peanut, tree nut, or other nut-based foods to camp.

INTERRUPTIONS AND DISTRACTIONS

Children who are disruptive will be separated from the group.

LOST AND FOUND

Please ensure ALL your child's belongings, including reusable water bottles, are labeled with your child's full name so we can return it to them should they be misplaced.

MEDICAL CARE

We can only apply over-the-counter topical medicines such as sunscreen and insect repellent. We will apply antiseptic and bandages to minor scrapes. You, or your surrogates identified above as authorized for pickup will be notified of more serious situations. 911 is the fallback in case of emergencies.

PROGRAM PHILOSOPHY

To keep our children entertained, active and safe while their parents play mas.

REFUND POLICY

There will be an administration fee of \$50.00 per camper withheld on all refunds.

In the event that a family must cancel due to medical reasons, a credit note may be offered with a doctor's note. Only a credit note for future camps is available. Although we benefit from a very high approval rate from the families who choose our camp, we make no guarantees that every child will appreciate our efforts. Therefore, in the unlikely event that a child is unhappy with our program, a refund will NOT be provided.
